General Comment:**COGCC Inspection Report Summary**

On Tuesday 10/12/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Miller5, at Location # 417475 in Garfield county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Also location is within or in close proximity to the 411 water protection area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad, there is no evidence of a tracking pad at time of inspection.

C/A's (Debris and pad stabilization) from document # 700702793 have been completed.

During this inspection the following compliance issues were observed:

1. Cut slope shows signs of lack of stabilization and erosion.
2. Access road shows signs of being washed out with the ditches failing.

Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
