General Comment:

This is an environmental inspection to document status of Remediation 19830.

Fence pit/open excavation to prevent wildlife access. Fencing should be maintained during regular facility visits. Maintenance of fencing and compliance with COGCC rules is the responsibility of the operator, not just the contractor hired to conduct the work. Operator informed of

Exploration and production waste (E&P waste) is strictly regulated by COGCC under Rule 905. Impacted oily soil from spills are considered E&P waste and may only be treated or disposed of via methods outlined in Rule 905.e.

Operator was observed to have created an offsite treatment/holding area for impacted soil on an offsite location (COGCC Location 324500) in violation of Rule 905.e. Operator must immediately cease transportation and storage of impacted material that is not in compliance with COGCC rules. See corrective action on inspection 700600320
