Evidence of a fire found at this tank battery. Fence post is charred and burned remains of tank found during inspection. During visit with landowner on 11/3 the landowner showed inspector video that he took of fire that he said occurred in May 2021.

No Form 22 Accident Report or Form 19 Spill Report has been submitted to the Commission documenting fire and associated spill in violation of rules 602.g and 912.b. Operator shall submit required Form 19 and Form 22 as required per rule. See corrective actions.
