**General Comment:****COGCC Inspection Report Summary**

On Thursday 10/21/2021 at approximately 0900, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus J31NEB, at Location # 334591 in Garfield county Colorado.

While there, I observed well was shut in. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

During this inspection the following compliance issues were observed:

1. Two vertical unit separators includes 2 glycol storage tank, storage vessel contains no labeling to specify capacity or chemical hazard information.
