Comment: There is one culvert along the access road that is still filled in with sediment. Other culverts along the road have been cleaned out and repaired. Areas of erosion along the road were graded and repaired. Grading has pushed soil blocking stormwater flow to one of the culverts. There are areas of the road and road side with insufficient BMP stabilization. Additional BMP's are required for long term stabilization of the access road.

Corrective Action: Install or repair required BMPs per Rule 1002.f.(2).
