RE: CONSENT AND AGREEMENT FOR THE SCHEIDT STATE 32-16 RE-ENTRY  
Township 1 North, Range 67 West 6<sup>th</sup> PM  
Section 16: SWNE (the "Lands")  
Weld County, Colorado

Mr. and Mrs. Veit:

This consent and agreement is between Kerr-McGee Oil & Gas Onshore LP ("KMOG") and the undersigned which outlines the operations referenced above and the terms and condition agreed to by the parties for the operations as described herein. The abandoned SCHEIDT STATE 32-16 ("Well") located on the Lands needs to be re-entered and re-plugged to comply with present day standards set forth by the Colorado Oil and Gas Conservation Commission ("COGCC"). Prior to commencement of these operations, the COGCC requires the Operator to inform you, and to seek your consent for the operations set forth herein. A plat is enclosed depicting the location of the Well according to records on file with the COGCC. Kerr-McGee Oil & Gas Onshore LP ("KMOG") needs to locate the abandoned wellbore, which is currently cut and capped below grade, bring it back to the surface, and permanently plug and abandon the Well according to the COGCC's current rules and regulations for well abandonment operations. Following the completion of these activities, KMOG will cut the Well below grade and reclaim all disturbed areas to as near a condition that existed immediately prior to entering the Lands for these activities. KMOG shall deep rip the areas disturbed by KMOG's operations on the well to a minimum depth of 18" but not to exceed a depth of 24" in order to alleviate compaction of the ground. Sod clods will be sufficiently broken down by KMOG. KMOG shall reseed the disturbed Lands with a dry land all grass pasture mix, from King L.A Hearne Company or comparable seed mix from another distributor. By this letter, you consent to KMOG's entry on to the Lands to conduct all necessary operations on the Well. This consent is granted on the express condition that KMOG assumes responsibility for and will indemnify and hold Dolf Veit and Susan Veit (Owners) harmless from and against, all claims and liability for any real and personal property damage or personal injury caused by or resulting from any negligence of KMOG while performing the above stated operations on the Lands. Additionally, and as a condition to your consent of KMOG's operations, and following the completion of KMOG's operations on the Well, KMOG agrees to repair or replace that section of fence approximately 50 feet in length that is currently disassembled along the southern portion of the Lands. Furthermore, KMOG's agrees to repair, replace, or pay for other damages to the Lands and real or personal property, caused by KMOG's operations on the Lands. NEITHER PARTY SHALL BE LIABLE IN AN ACTION INITIATED BY ONE AGAINST THE OTHER FOR SPECIAL, PUNITIVE, INDIRECT OR CONSEQUENTIAL DAMAGES RESULTING FROM OR ARISING OUT OF THIS AGREEMENT, INCLUDING, WITHOUT LIMITATION, LOSS OF VALUE, LOSS OF PRODUCTION, LOSS OF FINANCIAL ADVANTAGE, LOSS OF PROFIT OR BUSINESS INTERRUPTIONS, HOWEVER SAME MAY BE CAUSED. Any payment for damages by KMOG to you will constitute a full and final release of any and all claims that the undersigned may have against KMOG, its affiliates, employees, agents, and consultants for any and all past or current operations.

Please acknowledge your consent to the proposed operations and acceptance of the terms and conditions contained herein by signing, dating in the space provided below, and returning this consent and agreement to the undersigned via separate instructions.
