comment:	Oxy failed to comply with the approved Form 2A's for Location ID 331236 (Doc.# 400489957) and Location ID 435424 (Doc.# 400509105) regarding the approved access road; therefore, also violating Rule 1002.e.(4) to minimize surface disturbance.		
Corrective Action	L	Oxy shall come to an agreement with KPK on which access road to utilize. If all parties agree to utilize the new Oxy access road, then Oxy shall reclaim the pre-existing access road illustrated in Photo #1. If all parties agree to utilize the pre-existing access road, then Oxy shall reclaim the new Oxy access road that was not approved. Oxy will be given two weeks to reach an agreement.
