Corrective Action: Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Operator Comment: Confluence hired Advanced Contracting Group to perform final reclamation on the subject location from 11/18 - 11/21/2021. A blade was used to recontour a few spots and correct drainage. A high-speed disc was then used to prep the topsoil. A drill seeder was used for seeding, followed by straw mulch being spread and crimped into to soil. Please see the attached picture that shows the subject location post-final reclamation.

As mentioned by Inspector Chris Binschus in Insp 697502961, the main access road is pre-existing and is used to access a ditch crossing further to the northeast, thus it was not part of these final reclamation activities.
