Based on historic aerial imagery, it appears the Operator performed final reclamation activities for the well location and well location access road. However, at the time of this inspection, the access road is evident and shall be reclaimed per Rule 1004 standards.

Evidence of desirable plant species was observed at the well location; however, the well location will remain in-process. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
