<b>STORMWATER COMMENTS</b>  Previous inspections observed that control measures on the Location were missing or insufficient per good engineering practices: -Control measures to stabilize/protect cut slopes of the Location are missing or insufficient.  Inspection required Operator to comply with Rule 1002.f by 10/19/2021.  It was observed in this inspection that control measures to stabilize/protect the cut slopes remain missing or insufficient.  It was also observed that the containment BMP around tanks on the west end of the Location has not been maintained in proper functioning condition.
