There is a notice of intent to abandon the well. Upon plugging and abandonment, final reclamation will need to be completed within 3 months on cropland. Soils must be properly decompacted by cross ripping to at least 18 inches in depth and adequately tilled. The surface owner specified crops will need to be re-established and any undesirable or noxious weeds will need to be controlled. The access road, well site, and associated tank battery facility will need to be reclaimed per the 1004 Rules.	CostaR	12/08/2021
