Comment Operator has performed interim reclamation activities after the first reported production date of June 2019. After two growing seasons, there was little to no germination of desirable plant species. Interim reclamation areas consist mostly of Kochia and Russian thistle. Note- Operator is managing weeds and mowing operations have been performed. Refer to the attached inspection photos.

Corrective Action Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards.
