

The well is located 1000 ft. ( (N) (S)) of North Line and 1003 ft. (E) (W) of West Line of NE/4, Section 19-9N-53W.

The elevation above sea level is 4244 ft.

Details of Plan of Work: (State names of and expected depths to objective sands; Show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work.)

Captioned well was completed as a Dakota sandstone producer on 1-14-53. Pumped 82 barrels oil, 4 barrels water, in 24 hours from perforations 5012-5019 feet. Present production is 20 barrels oil, trace of water in 24 hours.

We propose setting bridge plug between Muddy and Dakota reservoirs and perforating the casing opposite the Muddy at approximately 4910 to 4914 feet. After testing Muddy plug will be drilled out. Production will be commingled from the Dakota 5012-5019 feet and from the Muddy 4910-4914'.
