On 12/14/2021 COGCC staff, Kris Neidel inspected the Ridgeview #32-16-1. The weather was 45 degrees and snow covered most of the ground. The snow cover made observation of the soil difficult. The well was PA and all production equipment has been removed. The flare pit had part of the berm removed and the bottom appeared to have been disturbed with an excavator recently. Part of the secondary containment was removed at the Treater and Tank battery. There were multiple piles of soil. There was a pile of what appeared to be cement wash out. There is a Remediation project for Rule 911 for this location. Corrective Actions: The wash out cement pile shall be removed and not incorporated in reclamation. Approved workplan to delineate any remaining impact shall be completed at a time where the ground is observable (not covered in snow). See photos.
