Oil ring present on perimeter of pw pit product of faulty separation at location. Separation process has been serviced/repared. Oil ring has remained in place since discovery. PW sent to pit continually rehydrates oil product during normal production activities.

Impacted soils around pump shed identified in FIR (Doc #688000547). "New Spill" will be investigated to determine root cause of release and remediation of impacted soil from E&P waste will be conducted.
