Operator Comment: It is understandable that one might assume that final reclamation has not been completed at the DC-3 location since a portion of the gravel pad remains. However, the current configuration of the former DC-3 location was incorporated into the Final Reclamation Plan approved by the Bureau of Land Management (BLM) Tres Rios Field Office (TRFO). The final reclamation of the DC-3 location presented an opportunity to incorporate a designated public parking area adjacent to a proposed off-road vehicle trailhead, which is consistent with the current BLM TRFO management plan. A copy of the approved Sundry Notice and DC-3 Final Reclamation Plan are attached to this FIRR. The area surrounding the parking area was been re-contoured and re-seeded in October 2020 but the vegetation does not yet meet the standard for final abandonment.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Reclamation inspector has reviewed the attached final reclamation plan. Location will be re-inspected for revegetation success within the reclaimed portion of the project area.
