Details of Plan of Work: (State names of and expected depths to objective sands: Show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work.)

Well commenced June 19, 1951. 187 feet of 10 3/4- inch surface casing was set and cemented June 20, 1951. 9-inch hole drilled with rotary to total depth of 5610 at the base of the Lakota Sand. All formations dry. Hole will be filled with extra heavy mud from total depth of 5610 to the base of the surface pipe at 187 feet. Hole will be bridged with a wooden plug and 15 sacks of cement placed in well from 187 feet to 157 feet. Surface casing will be filled with heavy mud from 157 feet to 20 feet, and hole will be filled with 10 sacks of cement from 20 feet to surface. A ten foot joint of heavy 3-inch pipe will be imbedded six feet in the cement with 4 feet showing above ground level to permanently mark location. Screw cap will enclose top of pipe.

Well was drilled by the E. K. Carey Drilling Company of Denver, Colorado. Work was done under the supervision of Joe Hurley, Drilling Superintendent for the E. K. Carey Drilling Company.
