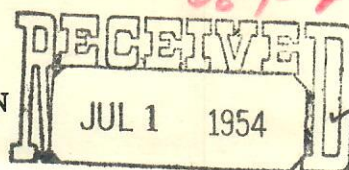

THE WELL TO BE DRILLED WITH ROTARY TOOLS AND IN EVENT OIL OR GAS PRODUCTION IS DISCOVERED THE WELL IS TO BE CASED WITH 5 1/2" CASING AND CEMENTED WITH 300 SACKS OR MORE OF CEMENT.
