On 01/24/22, my supervisor, Adam Kraich, attempted to make contact with complainant who indicated that on 01/24/22, they were experiencing excessive noise.

I performed a complete site inspection of the oil and gas location and associated wells in area. At time of inspection I did not observe any unusual noise in or around location. I performed a 24-hour sound study. Study appears to be out of compliance of the COGCC rule 423.(1).A
