COMMENTS:

Following the previous 6 months of FGR combustion device tie-in mitigation, BCEI has seen progress with this well's Bradenhead but believes that it would benefit from an additional round of 6 month blowdown mitigation. This progress can be seen in the blowdown trends (charts attached). However, there is still high pressure as demonstrated during the bradenhead test conducted 1/31/2022 (Form 17 doc# 402946245) reporting 150 psi. After analysis was completed of the Bradenhead gas and compared with that of production gas, it is clear that the bradenhead gas is microbial and likely biogenically sourced. The higher concentrations of Hydrogen and atmospheric gases in the bradenhead do not resemble the composition of the production gas, BCEI believes that the biogenic sources of the bradenhead gas will become exhausted over time given the prescribed mitigation strategies. For these reasons, BCEI is confident in the efficacy of this mitigation program and is requesting that this mitigation plan be extended for an additional 6 months.
