Refer to document #699803816 inspection conducted on 11/30/21. All previous corrective actions have been completed.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1) Location lacks stabilization. Insufficient tracking BMP at entrance to location with a corrective action date of 2/15/22.

- Location is located in a high priority habitat area.
