Operator Comment: The access road / crossing are maintained as needed. Runoff water noted in inspection photos is coming from drainage areas above the water crossing and is laden with naturally occurring sediment that is coming from areas above the crossing. The road and crossing are constructed in alluvial deposits with a high rock content which helps to stabilize the crossing and prevents down-cutting by occasional traffic. The crossing and occasional light truck traffic are not contributing significant sources of sediment to the snow melt runoff that occasionally runs in this drainage.
