Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the STATE 08-36 wellhead cut and cap. The wellhead will be cut and capped per COGCC rules. The flowline was previously abandoned on 04/15/2019, and the COGCC was notified on Form 44 Document number 402263524.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, where applicable. A grab confirmation soil sample will be collected at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
