 Field Inspector Actions:
 On 2-1-2022, I Tom Beardslee area field inspector have been assigned a complaint received by COGCC staff in reference to snow on row. The complainant Rayman Cornmesser stated the issues were occurring on ROW/development and well access roads. On 2-1-2022, I attempted to make contact with the complainant. I had to leave a voice mail, when he attempted to call back I had no service and he left me a voicemail. I contacted complainant again on 2-11-2022, complainant stated that Evergreen was not cleaning snow from the development road or to location within the development per there surface use agreement. I informed the complainant that COGCC does not regulate such contracts between landowners and operators and that COGCC does not have any rules requiring operators to plow snow as long as it is not causing storm water issues
 I performed a complete site inspection of the oil and gas location and associated wells in the area.
 No violation of COGCC rules where observed at the time of the inspection. Although I could not reach the Hill location noted in the complaint due to snowpack on steep hill leading up to location.
