Comment: The undesirable vegetation at the location has been mowed since previous inspection. The abandoned facility near the County Road has not been properly reclaimed. The soils need to be decompacted by cross ripping to a depth of 18 inches and should be sampled to evaluate soil suitability. It is unknown if additional reseeding was performed. The location consists mostly of undesirable weeds which will require ongoing weed control.
