WSP USA (WSP) was contracted by Kerr McGee Oil & Gas Onshore LP (Kerr-McGee) to complete final reclamation inspections at plugged and abandoned (P&A) well sites located in Weld County, Colorado. The reclamation inspections were conducted in accordance with Colorado Oil and Gas Conservation Commission (COGCC) Rule 1004.

The former ROCKY MOUNTAIN FUEL E 4 well (API: 05-123-09285) was P&A'd on March 24, 2006, as identified in the Form 6 Document Number 1968301. On April 1, 2021, WSP conducted a final reclamation inspection for the former ROCKY MOUNTAIN FUEL E 4 well pad (Location ID: 406730) and has determined that the site is in compliance with final reclamation requirements per COGCC Rule 1004. The former ROCKY MOUNTAIN FUEL E 4 well is located in a residential subdivision. The location was over excavated for wet and dry utilities, road installs and homebuilding activities. Under the operational control of the developer the well pad and tank battery have been reclaimed. The tank battery had road base removed and topsoil imported. The tank battery was located 0.28 miles north of the P&A'd well site and also located within the residential subdivision. WSP personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. A general site location map is included as Figure 1; and the Site Map displaying the location of the reclaimed site on aerial imagery is included as Figure 2. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. The photographic log is included as Attachment 1.

The previous land use for the former ROCKY MOUNTAIN FUEL E 4 was defined as pasture based on Google Earth Imagery. The land use has changed and is now a residential subdivision. A Form 4 Sundry Notice requesting final reclamation status has been prepared noting this land use change for the submittal to the COGCC. This letter will be included as an attachment to the electronic Form 4 submittal.








FIGURE 2
