Comment: Cobble BMP in the western project area is not adequate and is full of sediment and channeling is occurring within the fill slope. Erosional rilling is occurring on the well pad cut-slope where sparse vegetation is present. Sparse vegetation also observed on fill slopes.

Corrective Action: Install and maintain stormwater BMPs and erosion controls to stabilize erosion within the project area (well pad cut and fill slopes). Stormwater and erosion controls need to be selected, sized, installed, and maintained according to good engineering practices, and remain in place until the location is stabilized with desirable perennial vegetation. Corrective action is backdated as previous corrective action is not addressed.
