COGCC Inspection Report Summary
 On Wednesday 2/9/22 at approximately 12:00 hours, I, Inspector Corey De Paolo, Conducted a follow up inspection at TEP ROCKY MOUNTAIN LLC AMERICAN SODA-67S96W /2NWNW, Location #324178 in Garfield County Colorado.
 Refer to document #699803892 inspection conducted on 12/20/21. Previous corrective actions have not been completed. While there, I observed normal production operations.
 During this inspection the following compliance issues were observed:

- 1) Vent pipe on tank open ended with a corrective action date of 2/17/22.
- 2) Rill erosion occurring on berm and in ditch. Insufficient velocity checks located in ditch with a previous corrective action date of 1/4/22. Location lacks stabilization. Insufficient tracking BMP at entrance to location with a corrective action date of 2/25/22.

- Location is located in a high priority habitat area. Additionally the location is located on the edge of a 411a surface water intermediate buffer zone. All drainages contribute to the Colorado River.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
