**Photo 4:** Photo taken from the slopes on the west end of the Location. Photos show erosion degradation documented in the 3/25/2021, 4/30/2021 and 6/10/2021 inspections. Operator appears to have placed two straw wattles within eroding areas of the slope, as well as a single large rock; controls are inadequate per good engineering practices to address stabilization and erosion degradation issues on the slope. Additionally, wattles do not appear to have been correctly installed (trenched and backfilled).

Controls measures to address the gully erosion, and to stabilize the remaining, unstabilized slopes of the Location remain missing or insufficient in accordance with good engineering practices.

**Photo 5:** Photo taken from the slopes on the west end of the Location. Photos show erosion has persisted on the slopes. Photos also show the two straw wattles placed by Operator within areas of the erosion; controls are inadequate per good engineering practices to address stabilization and erosion degradation issues on the slope. Additionally, wattles do not appear to have been correctly installed (trenched and backfilled), and stormwater has cut beneath sections of the wattles.
