The water line installation project will be completed by mid-April 2022, after which all equipment and materials will be removed, and all disturbed areas will be cleaned up and restored to their pre-existing condition. All equipment and materials are staged / stored in such a manner so as to not interfere with site access, or access by emergency response vehicles (if needed).
