This location does not comply with Rule 1004. Operator has failed to reclaim the associated access road, which was not pre-existing prior to the development of the location. The associated access road is within cropland; therefore, the access road should have been reclaimed by 11/17/2021.

Operator has reclaimed the well location, tank battery and the flowline area with the evidence of drill rows and straw crimped mulch. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
