To Whom It May Concern:

In July of 2019 Black Hill Plateau Production, LLC ("BHPP") and Laramie Energy, LLC ("Laramie") submitted a Form 10 Transfer of Operatorship to the Colorado Oil and Gas Conservation Commission ("COGCC"). The Form 10 (Document #402096828) that was submitted to the COGCC in 2019 was **correcting an administrative error** that presented itself after the transfer of assets from BHPP to Laramie through that certain Purchase and Contribution Agreement dated effective January 29, 2018.

It was agreed by both parties that BHPP would retain all liability and responsibility for all corrective actions related to the reclamation of wellsite locations referenced on the attached Exhibit "A".

It is Laramie's intent to transfer the referenced wellsite locations to BHPP so as the Operator they can perform and manage any corrective actions related to the final reclamations of the wellsite locations referenced on Exhibit "A". The specific pads will then be inspected for final reclamation so BHPP could be able to release bond blanket plugging bond #2006-0007.
