Below is a list of items that will need to be corrected before the Form 9 can be approved.</p> <p>Problem 1: Both the Intent and the Subsequent listed the leases on their respective Wells and Facilities lists. The COGCC does not transfer leases. Solution 1: Since the Intent notifies the COGCC of a transfer and the subsequent is what actually transfers the items, please resubmit the Subsequent Wells and Facilities Transferred list omitting the leases from the list.</p> <p>Problem 2: The Buyer Notified Local Govt. Attestation is inadequate. Solution 2: Please resubmit the Buyer Notified Local Govt. Attestation using the attached guidance to revise the form. Please refer to page 6 of the guidance for information on revising the attestation. Local Government Designees (LGDs) for participating counties can be found here.</p> <p>Problem 3: I have identified five related Wells and Locations that were not accounted for in your transfer documentation. They are as follows: Locations with the following IDs - 312187, 388237, 388241 Wells with the following API, Facility ID and Location IDs – 075-06161, 319309, 388237 and 075-06166, 219312, 388241 Solution 3: The unaccounted for Wells and locations must be accounted for by one of the following ways: Solution 3a – Add the wells and locations to the Wells and Facilities Transferred list in the Subsequent. Solution 3b – Generate and submit a Related Wells and Facilities – Not Transferred List. If not transferring the wells and facilities, we will also need a Seller Retains Responsibility Attestation. Guidance for this attestation can also be found in the attachment.</p> <p>Problem 4: I have also identified one related incident not accounted for. The incident is an Unresolved Field Inspection with Corrective Action. Solution 4: The Unresolved Field Inspection with Corrective Action is document #693600475, dated 09/21/2021. The FIR with an outstanding corrective action is a transferable item that must be accounted for in the Form 9 in one or more of the following ways. 1.If the compliance responsibility for such an FIR transfers to the buyer include that FIR on a Related Incidents Transferred list. 2.If the compliance responsibility for such an FIR is retained by the seller include that FIR on a Related Incidents Not Transferred list and provide a Seller Retains Responsibility Attestation.
