INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with COGCC Rule 911, this form serves as notification for the abandonment and removal of the Nelson 24-34 flowline. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during abandonment activities. Field observations and photo documentation will be recorded in a field inspection form for submittal to the COGCC.

Discrete soil samples will be collected for laboratory analysis either in any area of observed hydrocarbon impacts, or along the flowline from native material and below the flowline risers. GPS data will be collected for all soil sample locations. Soil samples will be submitted for laboratory for analysis of Organic Compounds in Soil, TPH (C6-C36), and Soil Suitability for Reclamation by COGCC approved methods. Refer to the Wellhead and Flowline Location Map. A sample location figure will be provided in the Supplemental Form 27.

If groundwater is encountered during decommissioning and/or abandonment activities, a grab sample will be collected as soon as practical. If contaminated soil is in contact with groundwater or if free product/hydrocarbon sheen are observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260.

☐ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Assessments will be conducted during the removal of this off-location flowline (estimated to be 2,200 feet in length) approximately every 250 feet. Laboratory soil samples will be collected below the flowline risers and in close proximity to sensitive areas, such as wetlands, HPH sensitive wildlife habitats, and 100-year floodplains. The flowline and adjacent sub-surface will be inspected for any visual and olfactory indicators of potential failure and hydrocarbon impacts. Soils will be field screened below the flowline and if suspected impacts are observed, a soil sample will be collected for an initial assessment and submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, and TPH (C6-C36). If analytical results indicate the presence of organic compound concentrations, the sample will be analyzed for the full Table 915-1 suite. GPS data and photo documentation will be recorded for each inspection/sample location.
