**General Comment:**

This is an environmental inspection of the second E. Stieber Flowline spill (481906). A third party COGCC representative, arrived onsite on April 5, 2022, to perform an Environmental Inspection and oversee initial spill response activities for the latest spill. The third party COGCC representative returned on April 7, 2022, to perform an additional Environmental Inspection.

Initial spill response activities included hydrovacuuming. Hydrovac crews removed pooled liquids at the surface of the excavation. The break in the flowline was exposed on April 5, 2022.

During these inspections the following compliance issues were observed:  
Material handling - Inadequate BMPs: Comply with Rule 1002.f.(2)

The work site is in close proximity to a residence, surface water, public roadway and domestic water well.

Any corrective actions from previous Forms that have not been addressed are still applicable.
