Dear Sir:

Effective immediately the permit to complete the Dubois #5 in the "O" Sand Formation is hereby withdrawn. Any work to complete this well in the "O" sand formation is to be stopped immediately. Based on information that was received today, the Dubois #5 was found to be located less than 1200 feet from Advantage Resources' Dickinson #2. This is in violation of the minimum distance between wells completed in the same formation required in COGCC Rule 318 a.

On the original "J" Sand application to drill, a waiver was signed by Advantage Resources, which provided approval to drill the well less than 600 feet from the lease line. When the "O" Sand Formation re-completion application was approved it was represented in your letter to the COGCC that the only well located within 1200 feet of the Dubois #5 was the Dubois #2. After the COCC was contacted by Advantage Resources, it was discovered that the Dickinson #2 was located approximately 1000 feet from the Dubois #5. The original waiver by Advantage Resources did not waive or make exception to the 1200 foot distance between wells completed in the same formation requirement of COGCC Rule 318.

This letter is being faxed and sent to your office today. COGCC Northeast field inspector Ed Binkley has been sent to the Dubois #5 site to shut down "O" sand re-completion operations and to prevent unnecessary expenditures.
