Comment At the time of this inspection interim areas appear to be colonized by seeded perennial grasses, rabbitbrush and sparse sagebrush. Annual undesirable plant species/weeds are very widespread. Due to livestock grazing and the short stature of perennial grass species, revegetation progress is unclear at this time. A follow up inspection will be conducted later in the growing season to determine if the Location is progressing towards 1003 standards.
