**General Comment:****COGCC Inspection Report Summary**

On Wednesday 4/13/22 at approximately 13:30 hours, I, Inspector Corey De Paolo, Conducted a follow up inspection at TEP ROCKY MOUNTAIN LLC UNOCAL-67S96W /2NWNE. Location #323884 in Garfield County Colorado.

Refer to document #699804135 inspection conducted on 2/11/22. Previous corrective actions have not been completed.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1) Location lacks stabilization. Insufficient tracking BMP at entrance to location with a previous corrective action date of 9/30/21.

- Location is located in a high priority habitat area. Additionally the location is located on the edge of a 411a surface water intermediate buffer zone. All drainages contribute to the Colorado River.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
