It was observed in this inspection that the overall reclamation status for the interim areas of the Location is "in process"; desirable plant germination appears to be progressing towards COGCC 1003 uniform standards on areas of the north and north east end of the Location. However, germination, or vegetative establishment was not observed, or observed to not be progressing towards a uniform standard on the east end of the Location; additional reclamation work required in these areas.
