**General Comment:****COGCC Inspection Report Summary**

On Monday 4/25/2022 at approximately 1000, I, Inspector Scott Ramsey, conducted a routine inspection at TEP RU 13-7, at Location # 323944 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management and 411 water protection. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

During this inspection the following possible compliance issues were observed:

1. Some Areas on access road show signs of lack of stabilization/ compaction/ degrading.
2. Some riling.
