Additional sampling will occur at the start and end point of both flowlines. Areas below the separator, and dehydrator will be field screened with a PID and/or Petroflag. If concentrations do not indicate a hydrocarbon presence, Maralex is requesting a reduced analyte list consisting of TPH/BTEX and Inorganics (SAR/EC/pH).
