 On Monday 5/2/2022 at approximately 1000, I, Inspector Scott Ramsey, conducted a Follow up inspection at TEP RMV 220-21, at Location # 335334 in Garfield county Colorado.  
 Any Corrective Actions from previous Inspections that have not been addressed are still applicable.  
 While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.  
 C/A's (valves on tanks missing caps/plugs and lack of stabilization) have not been completed from previous inspection document # 700703475. Therefore C/A dates remain the same (12/10/2021)  
 During this inspection the following possible compliance issues were observed:  
 1. Some access show signs of lack of stabilization. C/A date from previous inspection (12/10/2021)  
 2. Valves on tanks missing caps/plugs. C/A date from previous inspection (12/10/2021)  
 3. Staining at well heads.
