INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the plugging and abandonment of the Schmid 2-34 wellhead and the partial removal of the associated flowline. The flowline will be partially removed, and the remaining segment will be abandoned in place. Assessment activities began on April 20, 2021. Soil assessment activities were conducted in accordance with COGCC Rule 911.a.

On April 27, 2021, upon receipt of the laboratory analytical report for samples collected on April 20, 2021, historically impacted soil was discovered in the facility excavation. Laboratory analytical results indicated samples from exceeded the COGCC Table 915-1 allowable levels for 1-methylnaphthalene, 2-methylnaphthalene, and naphthalene. The release was reported to the COGCC in the Form 19 Initial dated April 28, 2021 (Document No. 402672715). The volume of the release is unknown. The impacted soil was excavated.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Between April 20 and November 10, 2021, soil samples were collected from the separator riser, flowline soil borings, Pothole01 excavation, and the wellhead excavation and field screened for total volatile organic compounds using a photoionization detector (PID). Based on PID readings at the flowline and separator riser, no soil samples were submitted for laboratory analysis. Based on PID readings from Pothole01 and the wellhead excavation, select samples were submitted for analysis. The impacted soil was excavated. Analytical results indicated soil was in full compliance with Table 915-1 standards or within the analytical variability of the background samples at the extents of the two excavations. Therefore, further excavation was not warranted. The wellhead excavation is depicted on Figure 1.

On April 22, 2021, one groundwater sample was collected from the wellhead excavation for the full list Table 915-1 analyses. One background groundwater sample (Pothole-GW01) was also collected to assess the natural levels for inorganic analyses. Laboratory analytical results indicated groundwater sample GW01 exceeds the COGCC Table 915-1 allowable levels for Chloride Ion and Sulfate Ion. The groundwater sample analytical results are summarized in Table 1.

Following cut and cap operations, a soil gas survey was conducted. Five soil vapor points (SVP01 through SVP05) were installed adjacent to the former wellhead location. Field screening was conducted using a GEM 5000 gas meter. No methane was detected adjacent to the wellhead, and the soil vapor points were subsequently abandoned. Soil vapor point assessment details are summarized in the Form 27 Supplemental submitted on August 5, 2021 (Document No. 402766766).

Nine background soil samples (BG01@6', BG02@9', Native-BG03@12', Native-BG04@10', Native-BG04@19', Native-BG05@10', Native-BG05@19', Native-BG06@10', and Native-BG06@19') were collected for laboratory analysis of EC, SAR, pH, boron, and metals. Laboratory analytical results indicate arsenic and barium are naturally high in the native soil.

One background groundwater sample (Pothole01-GW01) was collected to assess the natural levels for inorganic analyses. Laboratory analytical results indicate sulfate is naturally high in groundwater.

Approximately 1,030 cubic yards of petroleum hydrocarbon impacted soil were transported to Buffalo Ridge Landfill in Keenesburg, Colorado, for disposal. Approximately three hydro-vacuum loads of impacted soil and groundwater slurry and approximately 2,718 barrels of impacted groundwater were removed from the excavation and transported to the Aggregate Recycle Facility in Weld County, Colorado, for recycling. Disposal records are kept on file and available upon request.
