COMMENTS:

TEP Rocky Mountain LLC (TEP) is reporting that the bradenhead on the SG 543-22 has been connected to the flowline as part of a Pressure Management Plan. On 5/10/2022, the SG 543-22 had a bradenhead pressure of 442 psi. This well has a surface casing depth (TVD) of 1,109' and has a threshold pressure of 333 psi. TEP performed a blowdown test and submitted the test results, via a Form 17, on 5/11/2022. A copy of the Form 17 is included in the "Related Forms" section. TEP monitored the bradenhead pressure after performing the test and determined that the bradenhead pressure continued to build and sustain pressures above the calculated threshold pressure. On 5/23/2022, TEP connected the bradenhead to the flowline as part of a Pressure Management Plan for this well. The average sales line pressure for this well is 120 psi. The bradenhead was connected to the flowline at the wellhead with 2" steel pipe and a check valve. A typical diagram is attached which depicts the bradenhead connection.
