On 5/24/2022 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

- Treat and remove tamarisk tree on access road. Corrective action back-dated to original date: 6/1/2020
- Stabilization measures need to be conducted on the well pad to prevent deep tracking and stabilize driving surface. Additionally, operator needs to close reclamation areas to vehicle traffic and educate personnel to avoid driving on reclamation areas in order to prevent site degradation. Corrective action date 6/30/2022.

Continued monitoring and management is needed to prevent re-establishment or spread of knapweeds. Revegetation is progressing within portions of the interim reclamation area where vehicle tracking is not occurring.
