Comment:

The Location appears to have been seeded with bluebunch wheatgrass, a native perennial grass, which is well established in the northern portion of the Location. Some areas of the Location to the south are dominated by undesirable and noxious species including field pennycress, cheatgrass and houndstongue. Given the vegetation community on the south of the Location, the site has likely not yet achieved total perennial, non-invasive uniform plant cover of at least eighty percent of reference levels. Operator may want to consider intervention in this area.
