Comment: The well location does not comply with Rule 1004. Gravel remains throughout the well location and minimal vegetation establishment was observed.

The tank battery remains to service the TA well API #123-15477 and is not associated with this inspection report.

Corrective Action:	Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil.
