Comment Operator has performed additional interim reclamation activities and desirable vegetation establishment was observed. Common rye was observed flowering along the southwestern interim reclamation area. Common rye growth was observed along southwest, south, east, northwest and western interim reclamation areas.

Corrective Action Operator did submit a Reclamation Plan and stated that mowing operations would occur to control Common rye. There was no specific dates on when mowing operations would occur likely due to environmental factors; therefore, COGCC is requesting the Operator provide a planned schedule for controlling Common rye now that it was observed flowering.
