Location has not been reclaimed in accordance with 1004 requirements; shrub establishment evident, however large majority of the Location is bare soils, or Undesirable and Noxious Plant species such as Jointed Goatgrass, Field Bindweed, Annual wheatgrass and cheatgrass. Pit on Location also has not been closed/reclaimed; access road has not been reclaimed; surface owner appears to be using area as a storage area, and the pit as a dumpsite; no variance to waive reclamation requirements of the Location or pit has been approved for this site.
