Comment: COGCC Environmental Staff inspection to witness confirmation soil sampling in excavation at wells in response to Spill ID 482208/Remediation Project 22960. COGCC met Apex and Civitas personnel onsite to witness sample collection and collect split samples. COGCC collected split samples from larger eastern excavation related to Spill 482208 for analysis of Table 915-1 metals. COGCC samples will be analyzed at Eurofins Denver and ALS Fort Collins.

During site visit COGCC and Civitas personnel observed the beginning work of decommissioning the associated tank battery. Remediation Project 22960 was not approved for tank battery and production facility decommissioning. Operator will submit a Form 27 Initial for decommissioning of the production facility.
